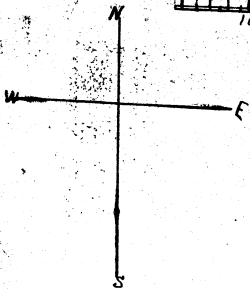
# PLAT OF THE WALLACE ORR PARK DEDICATION

## DESCRIPTION OF LAND PLATTED

The land embraced in the annexed Plat of the Wallace Orr Park of Aremac Co Michigan is described as follows: Beginning at (1) one (2) two (3) three and (4) four of sec 11, T19 N, R7 E, east of the 1st Meridian of Michigan; commencing at the Meander Post No. 1 in Section 11, Thence S 20° E continued and regardless of distance to the corner of sections 11 & 12, Thence South 128.17 feet to the south east corner of section 11 & 12, Thence East 1314 feet to the 1st Meridian, Thence North 38° 45' 10" East along the line of said section 11, Thence South 19° 30' East along the 1st Meridian Sec 2011, Thence South 1142 feet to Meander Post No. 1. The place of beginning.
