Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. If drain assessments are being collected for more than one (1) year, you may pay the assessment in full with any interest to date at any time and avoid further interest charges.

Persons with disabilities needing accommodations for effective participation in the Day of Review should contact the Drain Commissioner's Office at the number noted above (voice) or through the Michigan Relay Center at 7-1-1 (TDD) at least 24 hours in advance of the Day of Review to request mobility, visual, hearing, or other assistance.

Comments on the apportionment of benefits may be submitted to the Drain Commissioner in writing before the date of the Day of Review to the Arenac County Drain Commissioner at 120 N. Grove, PO Box 747, Standish, MI 48658 or to kczymbor@arenaccountymi.gov, or comments may be submitted in writing or verbally at the Day of Review. Comments submitted in advance must be received by the Drain Commissioner prior to the Day of Review to ensure consideration.

The following is a list of any county, township, city, or village to be assessed: Arenac County, Arenac Township, and Deep River Township.

You may appeal the Drain Commissioner's decision to revise the district boundary to the Arenac County Circuit Court within ten (10) days, and you may also appeal the determination of apportionments to the Arenac County Probate Court within ten (10) days.
