Proposal 1 - Mosquito Control

Shall the tax limitation under Article IX, Sec. 6 of the Michigan Constitution on General Ad Valorem Taxes within the City of Omer, County of Arenac, and State of Michigan be assessed on all real property within the City of Omer for the period of two years (2025-2026 inclusive.) Shall the tax limitation imposed under Article IX, Sec 6 of the Michigan Constitution of General Ad Valorem Taxes, within Turner Township, Arenac County, Michigan, be renewed at up to 1 mill (\$1.00 per \$1,000.00 of taxable value) for a period of four years (2025 to 2028) inclusively for the purpose of repair and maintenance of township roads; including but not limited to: new gravel, ditching, bridge repair, roadside brushing and mowing, road sign replacements, street light costs? If levied, this millage would raise approximately \$28,000.
