ALL DIMENSIONS ARE GIVEN IN FEET AND DECIMALS THEREOF.

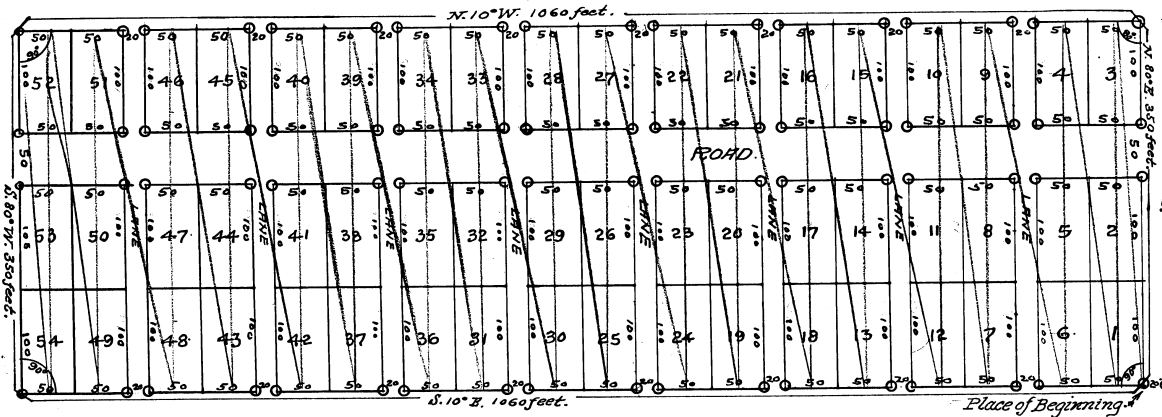
